

CLIMATE DECLARATION FOR **ASPHALT MIXTURES FROM HUDIKSVALL ASPHALT PLANT**

Functional unit: 1000 kg asphalt mixture

The climate declaration shows the emissions of greenhouse gases, expressed as CO₂-equivalents. It is based on verified results from a lifecycle assessment (LCA) performed as basis for an EPD*, in accordance with ISO 14025 and EN 15804.



Information about the product

The asphalt mixtures declared are manufactured at the asphalt plant Hudiksvall, by NCC Industry, Division Asphalt in Sweden. Asphalt plants manufacture asphalt mixtures for paving purposes. The asphalt mixtures that can be produced at the declared plant are hot mix asphalt (HMA), warm mix asphalt (WMA), soft bitumen asphalt (SA) and polymer modified asphalt (PMB).
